The purpose of this addendum is to provide clarification (s) to all prospective bidders.

Clarification for Addendum 1

- C1. Electrical Permit will be needed for this project. Per Harford County Department of License and Permits, permit must be obtained by a Master Electrician.**
- C2. Work is to be performed Mon - Thurs, due to events and weddings on site. Area is to be kept clean and accessible on weekends (Fri- Sun).**
- C3. See attached plan showing staging and access to pier. Temporary Access and Staging Area to be stabilized/seeded at the end of project. Stabilization to be included in item 1 Mobilization/ Demobilization.**

The pre-bid sign-in sheet is attached for your reference.

QUESTION NO. 1: Why is 16-245 Swan Creek have a prequalification of N? Most of the work is not considered Marine?

ANSWER NO. 1: The prequalification requirement in the bid states N. Please be advised, that the prequalification requirement is N-1; Pile Driving and excavation, NOT N. This prequalification requirement will remain N-1; due to the work on the Dolphin Piles and the need to access the pier from the water.


